- Sub: A. First-time/continuation of recognition and Registration/Additional/
Enrolment fees for the year 2008 - 09.
B. Change in the Management of the Institution.

Sir/Madam,

- A. 1. Please find enclosed herewith Annexure-I containing index number of institutions which have been granted continuation of recognition for the period mentioned therein. The schools which are granted continuation of recognition for the year 2007-08 and 2008-09 shall apply for continuation of recognition.
2. The continuation of recognition is also subject to the fulfillment of the following conditions:
- The schools shall strictly adhere to the Goa Board of Secondary and Higher Secondary Education Act 1975 and the Rules there under.
 - The schools shall strictly adhere to the Goa School Education Act 1984 and the Rules there under.
 - The school shall make available the staff, accommodation, furniture, equipments, telephone etc. for the purpose of examination of the Board including pre and post exam. work.
3. Breach of any of the above conditions shall attract the prevailing provision for de-recognition.
4. The norms circulated vide Circular No.21 dated 16th May, 2001 shall be strictly followed by the institutions while applying for the first-time recognition for any of the classes.
5. The taluka-wise time schedule for acceptance of application with Registration / Additional/enrolment fees (together) is as given below:

(ii) Tiswadi, Ponda & Mormugao	23/07/2008
(iii) Bardez, Pernem, Bicholim & Sattari.	25/07/2008

N. B. In case last day happens to be holiday immediate next working day shall be the last day.

The institution which fail to apply within the date, may apply with penalty which includes normal fees plus 50% of the normal fees, upto 31st July and thereafter may apply as time-barred with normal fees plus 50% normal fees plus Rs.20.00 per day till the date of submitting the application form.

It may be noted that the applications of candidates for S.S.C./H.S.S.C. Examination sponsored by the schools not recognised by the Board will not be accepted.

The application for first-time/continuation of recognition is required to be submitted in triplicate as per the enclosed proforma.

6. All institutions irrespective of period for which continuation of recognition has been granted are required to pay Registration/Additional/Enrolment fees every year as per the following rates which are subject to periodic revision.

The fees for granting recognition for additional subject is Rs.200/- per additional subject and for additional course in case of Vocational is Rs.1000/-(One time only). The Schools intending to introduce a new course/subject in the succeeding year shall apply by 31st October of the preceding year or before such date of the preceding year which shall enable the office to place the case in the Board's meeting of November/December.

It may be noted that recognition in additional subjects will not be granted if the additional subject is directly introduced in Std. X /XII. The recognition in additional subjects shall be sought by the school for introducing those subjects initially in Std. VIII or VIII and IX/XI and subsequently in Std. X / XIIth. Further it may be noted that a penalty of twice the regular fees shall be levied in respect of schools introducing the additional subjects in Std. VIII-X and Std. XI & XIIth simultaneously in the same year.


It is also informed that the Institutions introducing additional subjects/courses should apply for recognition to the Board simultaneously while applying for permission to Directorate of Education.

(i) Fees may be remitted by crossed D.D. payable at Porvorim or Panaji. D.D. should be drawn in favour of Secretary, Goa Board of Secondary and Higher Secondary Education, Alto- Betim Goa. All fees should be remitted by one crossed D.D. only.

(ii) Bank official will be accepting the fees in CASH in the Board's office from 10.00 a.m. to 1.00 p.m. on the dates mentioned at Sr. No. 5.

7. The conditions mentioned at 1(b)(i) & (ii) under Circular No.20 dated 10/04/2001 may be read along with this circular. The contents of this circular may be informed to all concerned and the acknowledgement of this circular may be sent by return of post.
