All the Heads of the Higher Secondary Schools are requested to send their representative with a letter of authority to collect the results and statement of marks on **Saturday 16th May, 2009** between 10.30 a.m. to 01.00 p.m.

If the statement of marks/statement of marks-cum-passing certificates along with the school results is not collected by the Heads of the schools through their authorised representatives on **Saturday 16th May, 2009** the same shall be collected from this Office on any working day through authorised representative. This Office shall not post such statement of marks/statement of marks-cum-passing certificates.

VERIFICATION OF MARKS/SUPPLY OF PHOTOCOPIES OF ANSWER-BOOKS

1. The proforma for verification of marks in absentia is enclosed herewith. The same may be photocopied or cyclostyled or downloaded from the website of Goa Board, at your end for distribution.
2. The application forms for (i) verification of marks in presentia and (ii) for supply of photocopies are available in the Board's Office @ Rs.5.00 (Rupees five only) each. The Heads of Institution shall purchase these forms as per the need of the Institution.
3. The norms for verification of marks in absentia/presentia and supply of photocopies are as circulated vide circular No. 24 dated 27th May, 2002 which may be brought to the notice of the students.
4. The verification of marks in absentia/presentia will be done as per the norms as per Circular No. 24 dated 27th May, 2002.
5. The Board shall make available the photocopies of the answer-books to the candidates on request as per the norms, as per Circular No. 24 dated 27th May, 2002.
6. The application for verification of marks in absentia/presentia shall not be accepted after seeing the photocopy of answer-book if it is shown after the last date for application for verification of marks.
7. Seeing photocopy of answer-book does not mean verification of marks.
8. The reason of having applied for photocopy of answer-book or of not being provided the photocopy of answer-book within the last date for application for verification of marks in absentia/presentia will not absolve the students from applying for verification of marks in absentia/presentia.
9. The fees prescribed in case of above for H.S.S.C. Examination March/April, 2009 shall be as follows:
 - i) Verification of marks in absentia**Rs. 75.00** per subject.
 - ii) Verification of marks in presentia.....**Rs.350.00** per subject.
 - iii) Supply of photocopies of answer-books.....**Rs.250.00** per subject.

10. Application along with relevant documents shall be forwarded by the Head of the Institution to the Secretary of this Board.
11. The fees shall be paid either by crossed D.D. drawn in favour of Secretary, Goa Board of Secondary and Higher Secondary Education, Alto Betim, Bardez Goa payable at Central Bank of India, Alto Betim Goa or any Bank at Panaji or by cash.
12. Incomplete application or application without the prescribed fees will be rejected and no correspondence shall be entertained in this regard.
