If the Statements of Grades/Passing Certificate-cum-Statements of Grades along with the school results is not collected by the Heads of the Schools through their authorised representatives on **7<sup>th</sup> June, 2011** the same shall be collected from this Office on any working day through authorised representative. This Office shall not post such Statements of Grades/Passing Certificate-cum-Statements of Grades.

VERIFICATION OF MARKS/SUPPLY OF PHOTOCOPIES AND RE-EVALUATION OF ANSWERSSCRIPTS

- The application forms (i) for verification of marks in absentia (ii) for verification of marks in Presentia of candidate/presentia with Parent or Guardian (iii) for supply of photocopies and (iv) for re-evaluation of Answerscripts are enclosed herewith. The same may be photocopied or cyclostyled or downloaded from the website of the Goa Board, at your end for distribution.
- The verification of marks in absentia/presentia and supply of Photocopies of Answerscripts available to the students will be done as per the norms in the Circular No. 24, dated 27<sup>th</sup> May 2002 & Circular No.10, dated 13<sup>th</sup> May 2011 , which may be brought to the notice of the students.
- The re-evaluation of answer-scripts will be done as per the norms as per Circular No. 10, dated 13<sup>th</sup> May, 2011. The same may please be brought to the notice of the students and all concerned.
- The application for verification of marks in absentia/presentia shall not be accepted after seeing the photocopy of answer-book if it is shown after the last date for application for verification of marks.
- The candidate applying for re-evaluation shall not be permitted to apply for photocopies of answerbooks of the same papers.
- Seeing photocopy of answer-book does not mean verification of marks.
- The reason of having applied for photocopy of answer-book or of not being provided the photocopy of answer-book within the last date for application for verification of marks in absentia/presentia will not absolve the students from applying for verification of marks in absentia/presentia.
- The fees prescribed in case of above for S.S.C. Examination March/ April, 2011 shall be as follows:
  - Verification of marks in absentia ..... **Rs. 75.00** per subject.
  - Verification of marks in presentia.....**Rs.300.00** per subject. + **Rs. 10/-** per application form.
  - Verification of marks in presentia with Parent/Guardian.**Rs.500.00** per subject.+**Rs. 10/-** per application form.
  - Supply of photocopies of answer-books...**Rs.200.00** per subject + **Rs. 10/-** per application form.
  - Re-evaluation of answer scripts **Rs.700.00** per subject +**Rs. 10/-** per application form

9. Application along with relevant documents shall be forwarded by the Head of the Institution to the Secretary of this Board.
10. The fees shall be paid either by crossed D.D. drawn in favour of Secretary, Goa Board of Secondary and Higher Secondary Education, Alto Betim, Bardez, Goa payable at Central Bank of India, Alto Betim, Goa or any Bank at Panaji or by cash.
11. Incomplete application or application without the prescribed fees will be summarily rejected and no correspondence shall be entertained in this regard.
