All the Heads of the Secondary Schools are requested to send their representative with a letter of authority to collect the results and Statement of Grades/Passing Certificate-cum-Statement of Grades on 04/06/2012 between 11.00 a.m. to 01.00 p.m. at the respective centres of distribution.

In case result booklet and Statement of Grades/Passing Certificate-cum-Statement of Grades are not collected by the Heads of the schools through their authorised representatives on 04/06/2012 the same shall be collected from this office on any working day through authorised representative. This office shall not post such Statement of Grades/Passing Certificate-cum-Statement of Grades.

VERIFICATION OF MARKS/SUPPLY OF PHOTOCOPIES AND RE-EVALUATION OF ANSWER-SCRIPTS

1. The application forms (i) for verification of marks in absentia (ii) for verification of marks in Presentia of candidate/Presentia with Parent or Guardian (iii) for supply of photocopies and (iv) for re-evaluation of Answerscripts are enclosed herewith. The same may be photocopied or cyclostyled or downloaded from the website of the Goa Board, at your end for distribution.
2. The verification of marks in absentia/presentia and supply of Photocopies of Answerscripts available to the students will be done as per the norms in the Circular 24, dated 27th May 2002 & Circular No.10, dated 13 May 2011, which may be brought to the notice of the students..
3. The re-evaluation of answer-scripts will be done as per the norms as per Circular No.10, dated 13th May, 2011. The same may please be brought to the notice of the students and all concerned.
4. The application for verification of marks in absentia/presentia shall not be accepted after seeing the photocopy of answer-book if it is shown after the last date for application for verification of marks.
5. The candidate applying for re-evaluation shall not be permitted to apply for photocopies of answer-books of the same papers.
6. Seeing photocopy of answer-book does not mean verification of marks.
7. The reason of having applied for photocopy of answer-book or of not being provided the photocopy of answer-book within the last date for application for verification of marks in absentia/presentia will not absolve the students from applying for verification of marks in absentia/presentia.

8. The fees prescribed in case of above for S.S.C. Examination March/April, 2012 shall be as follows:
 - i) Verification of marks in absentia Rs.75.00 per subject.
 - ii) Verification of marks in presentia Rs.300.00 per subject + Rs.10/- per application form.
 - iii) Verification of marks in presence Rs.500.00 per subject + Rs.10/- per application form of Parent/Guardian
 - iv) Supply of photocopies of answer-books.... Rs.200.00 per subject + Rs.10/- per application form.
 - v) Re-evaluation of answerscripts Rs.700/- per subject + Rs.10/- per application form.
9. Application along with relevant document shall be forwarded by the Head of the Institution to the Secretary of this Board.
10. The fees shall be paid either by crossed D.D. drawn in favour of Secretary, Goa Board of Secondary and Higher Secondary Education, Alto; Betim, Bardez-Goa payable at Central Bank of India, Alto Betim
11. Incomplete application or application without the prescribed fees will be summarily rejected and no correspondence shall be entertained in this regard.
12. The last date for accepting the application in the office of the Board shall be as follows:
 - i) For verification of marks in absentia/presentia 03/07/2012
 - ii) For supply of photocopies of answerscripts 13/06/2012
 - iii) For re-evaluation of answerscripts 13/06/2012
