Sub: Preparation of List of Voters for Election of Members of the Board
for the term 2013-2017.

Sir/Madam,

The list of voters for the election of Class – B “Elected Members of the Board” Categories III (a), III (b), IV, V, VI and VII have been prepared by this Office, and will be displayed in the Office of the Assistant District Educational Inspectors (A.D.E.I.) in each taluka for inspection from 10/12/2012 to 14/12/2012.

Application for any corrections, inclusion, deletions of names in the list of voters will be received in the Office of the Chairman, Goa Board of Secondary and Higher Secondary Education, Alto Betim, Goa from 10/12/2012 to 14/12/2012 on all working days during Office hours. Such applications should necessarily be forwarded by the Heads of the recognized Institutions certifying the correctness of the eligibility for any corrections, inclusion, deletion etc. of the name/s of the applicant/s in the respective list of voters. Heads of recognized Institutions should ensure that the names of Teachers on contract – full time/part time basis and appointed against leave vacancy and graduate scale teachers not teaching Std. IX & X are deleted from the voters lists as it has been noticed that these names have been included, violating the instructions for sending the names of voters to be included in the voters list vide Circular No.39 and 40 dated 28/09/2012 (for Secondary & Higher Secondary Schools) and Corrigendum No.GBSHSE/RP/Brd-Ele/2012/3613 dated 04/10/2012 (for Secondary Schools only).

However, information like age, sex, etc. against the names of voters which have not been sent in the voters list earlier may be forwarded through the Head of the Institution on or before 14/12/2012. Kindly note that incomplete information against the names of the voters on the voters list shall invite for disqualification.

Please note that any request for inclusion of names in the voters list will not be entertained after 14/12/2012.

The first list of voters and the final list of correction/inclusion/deletion etc of voters will be available on the Board's website from 10/12/2012 to 14/12/2012 and 14/01/2013 to 18/01/2013.

The final list of correction/inclusion/deletion etc. of voters will be available in the Office of the respective A.D.E.I. from 14/01/2013 to 18/01/2013.
