1. Note that Application forms for General stream i.e. Arts, Science and Commerce shall be the same. Application for Vocational stream shall bear the title “Vocational”.
2. Fees may be remitted by crossed D.D. payable at Porvorim or Panaji. D.D. should be drawn in favour of Secretary, Goa Board of Secondary and Higher Secondary Education, Alto Betim, Goa. All fees should be remitted by one Crossed D.D. only. Cash can also be deposited in Central Bank of India, Alto Betim – Goa.
3. Fees may also be paid in cash if the total amount is less than Rs.2000/- at the Board’s office between 10:00 TO 1.00 PM on working days.
4. It may be ensured that fees are necessarily paid as per the scheduled dates as specified at II above.
5. This Office will not accept the payment of examination fees made beyond the specified dates in the respective categories detailed at II above, even if the Bank accepts the same by oversight.

VI. HALL TICKETS

The list of candidates registered for the HSSC June, 2015 examination shall be displayed on the Board’s website www.gbshse.gov.in on 08/06/2015 along with their seat numbers and subjects offered. The hall tickets may be collected by the Schools from the Board till 11th June 2015. Thereafter from 12th June 2015 onwards, candidates may collect the Hall tickets from the centre conductor by producing proper identification documents.
